Region I MIEMSS Update September 2018

Protocol Update

EMS Protocol Update for 2018 is active, providers should have taken the course by July 1, 2018. Providers should have received a pocket protocol, if not please see your jurisdictions highest EMS official. Providers that have not taken their protocol by the July date will receive a letter not allowing them to run call as an EMS provider in the Region and if not taken the protocol by October they will have their Region I affiliations revoked. An updated list of providers who have not taken their protocol will be provided to the jurisdiction this week.

Recertification and MIEMSS Licensure System

- Every provider (EMR, EMT, CRT, and Paramedic) before their recertification date must sign on to the licensure system, under the applications tab select renewal to start the recertification process. If you have not received your new certification card call the Region I Office or MIEMSS Main Office for assistance.
- Providers can view their total credit hours towards recertification by going to training and clicking on reports. To
 view individual classes use the drop down date selection, click on the go button, then click on the small PDF icon
 button above the date drop down boxes.
- Everything that a provider needs to do such as affiliation, reinstatement application, application for initial certification, extension request, and change of address etc. should be done on this site.

The Licensure System is accessed by going to www.miemss.org and clicking on the large red provider login button at the bottom right of the screen. If anyone has trouble getting on the system they should call 1-800-762-7157 or 410-706-3666 ask for Licensure & Certification.

50/50 matching grants should be out in a few weeks, Mechanical Chest Compression devices have been added and can be applied for using this grant. Priority will be given to 12 Lead acquisition, then AEDs, and then to the mechanical chest compression devices.

2018 Campaign

This year's FPW campaign, "Look. Listen. Learn. Be aware. Fire can happen anywhere," works to educate people about three basic but essential steps to take to reduce the likelihood of having a fire—and how to escape safely in the event of one:

"LOOK" for places fire could start. Take a good look around your home. Identify potential fire hazards and take care of them.

"LISTEN" for the sound of the smoke alarm. You could have only minutes to escape safely once the smoke alarm sounds. Go to your outside meeting place, which should be a safe distance from the home and where everyone should know to meet.

"LEARN" two ways out of every room and make sure all doors and windows leading outside open easily and are free of clutter.

Also, Sparky the Fire Dog® has a new friend, Simon, who is helping teach this year's FPW messages – He's a smart, resourceful character who will join Sparky in spreading fire-safety messages to adults and children alike.

About Fire Prevention Week

Since 1922, the NFPA has sponsored the public observance of Fire Prevention Week. In 1925, President Calvin Coolidge proclaimed Fire Prevention Week a national observance, making it the longest-running public health observance in our country. During Fire Prevention Week, children, adults, and teachers learn how to stay safe in case of a fire. Firefighters provide lifesaving public education in an effort to drastically decrease casualties caused by fires.

Fire Prevention Week is observed each year during the week of October 9th in commemoration of the Great Chicago Fire, which began on October 8, 1871, and caused devastating damage. This horrific conflagration killed more than 250 people, left 100,000 homeless, destroyed more than 17,400 structures, and burned more than 2,000 acres of land.

Importance of Fire Prevention

In a fire, mere seconds can mean the difference between a safe escape and a tragedy. Fire safety education isn't just for school children. Teenagers, adults, and the elderly are also at risk in fires, making it important for every member of the community to take some time every October during Fire Prevention Week to make sure they understand how to stay safe in case of a fire.

On this site, you'll find loads of educational resources to make sure that every person knows what to do in case of a fire. We have everything from apps to videos to printables and much more, to make sure you have the resources you need to keep your family, your community, and your city safe.

Bring Awareness

While children under 5 and adults over 65 are at the highest risk for injury or death in a fire, people of all ages are vulnerable. In fact, the risk of a nonfatal fire injury is highest for those between 20 and 49, showing that fire safety education is essential for everyone. Additional risk factors include race, socio-economic status, education level, and geographic location.

The purpose of Fire Prevention Week is to bring awareness to the risk of death in case of a fire and provide educational resources to people of all ages, races, and socioeconomic status in order to keep everyone safe.

Getting to the call safely is the most important job you have! Buckle up! Remember Everyone Goes Home!

FACTS

- *A closed door may slow the spread of smoke, heat, and fire. Install smoke alarms inside every sleeping room and outside each separate sleeping area. Install alarms on every level of the home. Smoke alarms should be interconnected. When one smoke alarm sounds, they all sound.
- *According to an NFPA survey, only one of every three American households have actually developed and practiced a home fire escape plan.
- *While 71% of Americans have an escape plan in case of a fire, only 47% of those have practiced it.
- *One-third of American households who made an estimate thought they would have at least 6 minutes before a fire in their home would become life-threatening. The time available is often less. And only 8% said their first thought on hearing a smoke alarm would be to get out!



SAFETY TIPS

- MAKE a home escape plan. Draw a map of your home showing all doors and windows. Discuss the plan with everyone in your home.
- NOW at least two ways out of every room, if possible. Make sure all doors and windows leading outside open easily.
-))) HAVE an outside meeting place (like a tree, light pole or mailbox) a safe distance from the home where everyone should meet.
- PRACTICE your home fire drill at night and during the day with everyone in your home, twice a year.
- PRACTICE using different ways out.
-))) TEACH children how to escape on their own in case you can't help them.
-))) CLOSE doors behind you as you leave.

IF THE ALARM SOUNDS...

- If the smoke alarm sounds, GET OUT AND STAY OUT. Never go back inside for people or pets.
- If you have to escape through smoke, GET LOW AND GO under the smoke to your way out.
-))) CALL the fire department from outside your home.
